NEW COUNCIL CONVENES AT 6:49 P.M.

Mayor Tony Burriss asked Reverend Paul Tucker with First Presbyterian Church to lead in prayer.

Mayor Burriss called the new Council to order.

Mayor Burriss asked for a motion to elect a City Recorder. Alderman Gibson made motion to elect Sammy Dickey as the City Recorder. Alderman Overall seconded the motion. The motion was passed by all.

Judge Mark Johnson swore in new appointed City Recorder Sammy Dickey.

Mayor Burriss asked for a motion to elect a City Treasurer. Alderman Hammonds made a motion to elect Ricky Jackson to City Treasurer. Alderman Abbott seconded the motion. The motion was passed by all.

RESOLUTION #2011-R-1

Mayor Burriss asked for a motion to pass Resolution #2011-R-1 to hire Community Development Partners to administer services for CDBG Disaster Recovery Program to build a well out of the flood zone and purchase a rescue boat and truck for the Fire Department, accompanying Resolution 2011-R-2. A motion was made by Alderman Hammonds hire Community Development Partners. Alderman Jackson seconded the motion. The motion was passed by all.

RESOLUTION #2011-R-2

Mayor Burriss asked for a motion to hire Gresham, Smith, & Hargett for the engineering services for the CDBG Disaster Recovery Program. A motion was made by Alderman Hammonds to hire the firm. Alderman Overall seconded the motion. The motion was made by all.

OTHER BUSINESS

City Attorney, Richard Gossum informed council that resolutions must be passed to authorize \$615,000 Water & Sewer Revenue Tax Bond to renovate water tanks.

A motion was made by Alderman Gibson to pass the Initial Resolution #2011-R-3 to authorize the loan. Alderman Hammonds seconded the motion. The motion was passed by all.

A motion was made by Alderman Abbott to pass the Bond Resolution #2011-R-4 to authorize the sale of bonds. Alderman Hammonds seconded the motion. The motion was passed by all.
